**NOTICE TO ALL PROSPECTIVE BIDDERS ON THE MANDATORY SUBMISSION OF
THE PHILIPPINE GOVERNMENT ELECTRONIC PROCUREMENT SYSTEM
(PHILGEPS) CERTIFICATE OF PLATINUM REGISTRATION AND MEMBERSHIP**

Dear Ma'am/Sir:

This Notice is being issued to all prospective bidders (manufacturers, suppliers, distributors, contractors and/or consultants) of the Philippine Coast Guard (PCG) in view of the mandatory submission of PhilGEPS Certificate of Platinum Registration and Membership in compliance with Government Procurement Policy Board (GPPB) Resolution No. 15-2021¹ when participating in Competitive Bidding and Limited Source Bidding.

The aforesaid GPPB resolution further amends Sections 23.3 and 24.4.3 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, to wit:

"In lieu of the Class "A" eligibility documents mentioned under Section 8.5.2 of this IRR, the Bidder shall ONLY submit a valid and updated PhilGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of this IRR for purposes of determining eligibility." [Emphasis Supplied]

Anent this, all prospective bidders are hereby reminded to secure/maintain/update a valid PhilGEPS Certificate of Platinum Registration and Membership by ensuring that the following Class "A" Eligibility Documents covered by Section 8.5.2 of the 2016 revised IRR of RA No. 9184 are valid and/or updated:

1. Registration Certificate;
2. Mayor's/Business Permit² or its Equivalent Document;
3. Tax Clearance;
4. Philippine Contractors Accreditation Board (PCAB) License and Registration³;
5. Audited Financial Statements.

² The submission of recently expired Mayor's Permit together with the official receipt as proof that the prospective bidder has applied for renewal within the period prescribed by the concerned local government unit shall be accepted by the PhilGEPS for the purpose of updating the PhilGEPS Certificate of Platinum Registration and Membership
