

- The six (6) months warranty period against factory defect under normal usage shall be reckoned from the date of issuance of the Certificate of Final Acceptance. All replaced items due to said factory defects shall have a warranty period of six months. However, if the same defect occurred for two (2) consecutive times within the warranty period on a particular part/item and its attendant part, the warranty period shall be automatically extended for a period of eight (8) months after the expiration of the original warranty period.
- The said defective parts/item should be replaced within thirty (30) days from the date of delivery.
