INVITATION TO BID

Dear Sir/Madam:

The Coast Guard Logistics Systems Command (CGLSC) now invites bids for the procurement of the following projects:

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Interested bidder may obtain further information from **Coast Guard Logistics Systems Command** and inspect the Bidding Documents at the address given below from Monday to Friday, during office hours from **8:00 AM - 5:00 PM**.

A complete set of Bidding Documents may be acquired by interested Bidders on **12 October 2023 to 06 November 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person or through email**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The *Coast Guard Logistics Systems Command (CGLSC)* will hold a Pre-Bid Conference on **19 October 2023, 09:00 AM** at **Conference Room, 2nd Floor, Headquarters Coast Guard Logistics Systems Command Conference Room, 2F Muelle Dela Industria, Binondo, Manila** and through video conferencing/webcasting via zoom (**ZOOM ID: 894 6283 7151** and **Password: 563828**) which shall be open to all interested bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **06 November 2023, 09:00 AM**. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

Bid opening shall be on **06 November 2023, 09:00 AM** at the given address below at the **Conference Room, 2nd Floor, Headquarters Coast Guard Logistics Systems Command Conference Room, 2F Muelle Dela Industria, Binondo, Manila**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The CGLSC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
