## Repair and Renovation of NHQ-PCG Lobby and Kadiwa

- 1. The **Philippine Coast Guard**, through the General Appropriation Act (GAA) for 2023 intends to apply the sum of **Two Million Two Hundred Nine Thousand Six Hundred Sixty-Eight Pesos and 34/100** (**Php2,209,668.34**) being the Approved Budget for the Contract (ABC) to payments under the contract for **Repair and Renovation of NHQ-PCG Lobby and Kadiwa**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Philippine Coast Guard** now invites bids for the above Procurement Project. - 5. A complete set of Bidding Documents may be acquired by interested bidders on **06 September 2023 to 26 September 2023** from the given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic mail.
- 6. The Philippine Coast Guard will hold a Pre-Bid Conference at 10:00 AM, 14 September 2023 at the HSG Conference Room, Myers Building, 159 Roberto Oca St., Cor. Antonio C, Manila, 1018 Metro Manila, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **09:00 AM**, **26 September 2023** late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
- 9. Bid opening shall be from **10:00 AM onwards**, **26 September 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Bidders shall bear all costs associated with the preparation and submission of their bids, and the Philippine Coast Guard will in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

Bidders should note that the Philippine Coast Guard will accept bids only from those that have paid the applicable fee for the Bidding Documents.

The Philippine Coast Guard assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

In accordance with **Government Procurement Policy Board (GPPB) Circular 06-2005** - Tie-Breaking Method, the Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS," in the event that **two (2)** or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final bidder having the LCRB, based on the following procedures:

- a) In alphabetical order, the bidders shall pick one rolled paper.
- b) The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.

The Philippine Coast Guard reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
