- One-time delivery of all ammunitions to delivery site.

Post Qualification

- Conduct of following test parameters at the Supplier's facility (Local or Foreign, winning Supplier will shoulder all expenses such as meals, lodging and travel expenses)
- Firearms to be used during the conduct of test parameters will be provided by the PCG.
- Test parameters:
 - a. Physical Inspection 10 rounds per type of ammunition.
 - b. Test Firing 50 rounds per type of ammunition
 - c. Accuracy Test 25 rounds per type of ammunition
 - Cal 9mm (1.5" max. mean radius at 25 yards)
 - Cal .45 (1.5" max. mean radius at 25 yards)
 - Cal 5.56mm (1.8" max. mean radius at 200 yards),
 - d. Chamber Pressure Test 5 rounds per type of ammunition.
 - Cal 9mm (35, 000 psi max average)

Post Qualification

- Conduct of test parameters shall be concluded at the Supplier's facility. In the absence thereof, such suitable facility shall be provided by the Supplier without cost to the PCG including tools/equipment necessary for the accuracy and pressure chamber test.
- Firearms to be used during the conduct of test parameters will be provided by the PCG.
- Ammunitions used during the test parameters shall come from a representative sample of the procured ammunitions which shall be replaced by the Supplier and included to the total rounds to be delivered.
- Test parameters:
 - a. Physical Inspection 10 rounds per type of ammunition.
 - b. Test Firing 50 rounds per type of ammunition
 - c. Accuracy Test 25 rounds per type of ammunition
