The Philippine Coast Guard now invites bids for the following procurement of:

Supply and Delivery of 23 Units Desalination Equipment	PhP 160,000,000.00	Php 50,000.00	The winning supplier shall submit the required prototype within thirty (30) calendar days from receipt of Notice to Proceed. The Supply and Delivery of Twenty-Three (23) Desalination Equipment is within Ninety (90) calendar days from the approved prototype.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

*Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.*

Interested bidder may obtain further information from **Coast Guard Procurement Service** and inspect the Bidding Documents at the address given below from Monday to Friday, during office hours from **8:00 AM - 5:00PM**.

A complete set of Bidding Documents may be acquired by interested Bidders from **05 December 2024 to 26 December 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person or through email**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The **Philippine Coast Guard** will hold a Pre-Bid Conference on **13 December 2024, 09:30 A.M.** at the Conference Room, Second (2<sup>nd</sup>) Floor, Administrative Building, Philippine Coast Guard – National Headquarters, 139 25<sup>th</sup> St., Port Area, 1018 Manila, which shall be open to interested bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **26 December 2024, 09:30 A.M.** Late bids shall not be accepted.
