SUPPLEMENTAL/ BID BULLETIN NO. 02-2024

This Supplemental/Bid Bulletin No. 02-2024 is issued to include the following clarifications as integral part of the Bidding Documents issued for the **Supply and Delivery of Additional Fuel, Oil and Lubricants for CY-2024**.

Q1. Section VII. Technical Specifications. Rebates.

As discussed during the Pre-Bid Conference on 06 May 2024, the Technical Working Group (TWG) recommended the inclusion of the provision on rebates in the Technical Specifications.

A. Considering the merit of your request for the inclusion of provision on rebates in the Technical Specifications, It is hereby approved with the following details:

- The winning supplier may provide rebates equivalent to at least five percent (5%) of the total contract price, which shall be applied and accumulated within the contract duration of One (1) year or until the total contract price has been fully exhausted.

PCG and the winning supplier shall execute a separate agreement for the details and implementation of the selected option of the PCG using the aforesaid rebates.

Q2. Section I. Invitation to Bid. Item No.7 Bid Submission.

We respectfully request the procuring entity to move the submission and opening of bids to 22 May 2024, with price reference date of 14 May 2024. Your response to our queries is crucial with our bid submission and we will need ample time to prepare the necessary documents and proposal.
