- c. ensure proper waste management, marine conservation, and ecological sustainability of the island, in coordination with the LGU and other concerned government agencies;
- d. preserve and maintain the historical Spanish lighthouse and its land development as an added attraction;
- e. collaborate with other government agencies for the relocation of the informal settlers of the island;
- f. to conduct joint study for the appropriate ways forward to promote the preservation, conservation and the general welfare of the island; and

### ARTICLE III RESPONSIBILITIES OF TIEZA

TIEZA shall have the following duties and responsibilities:

- a. restore the old Spanish lighthouse as a tourist attraction in accordance with the rules and regulations of the National Historical Commission of the Philippines (NHCP);
- b. to include the construction of a Coast Guard station building within the five (5) hectare TIEZA's development site;
- c. to provide free and complete ingress and egress for the PCG personnel within the TIEZA tourism facilities in the exercise of the PCG functions;
- d. undertake tourism development in the island and revenue generation activities thereat, taking into account safety, security, sustainability, and environmental considerations;
- e. assist the PCG in preventing further human migration to the island; and
- f. to shoulder the cost of the land survey for the five (5) hectares.

# ARTICLE IV RESPONSIBILITIES OF PCG

The PCG shall have the following duties and responsibilities:

- a. ensure security of the island in coordination with the other security forces;
- b. administer, manage, and maintain active lighthouse and other coast guard facilities;
- c. prevent further human migration to the island;
- d. monitor and ensure the safety of all ships and watercrafts coming in, out and around the island, and the deployment of assets thereat;
- e. coordinate with concerned agencies for the proper zoning of the island; and
- f. f. enforcement of laws, rules, and regulations pertaining to maritime safety, maritime security, and marine environmental protection in connection with this agreement.
