- 4. Quotation exceeding the Approved Budget for the Contract shall be rejected.
- 5. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.

- 6. In case of two or more bidders Determined to have submitted the Lowest Cr and Responsive Quotation, the HSG-BAC shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.


